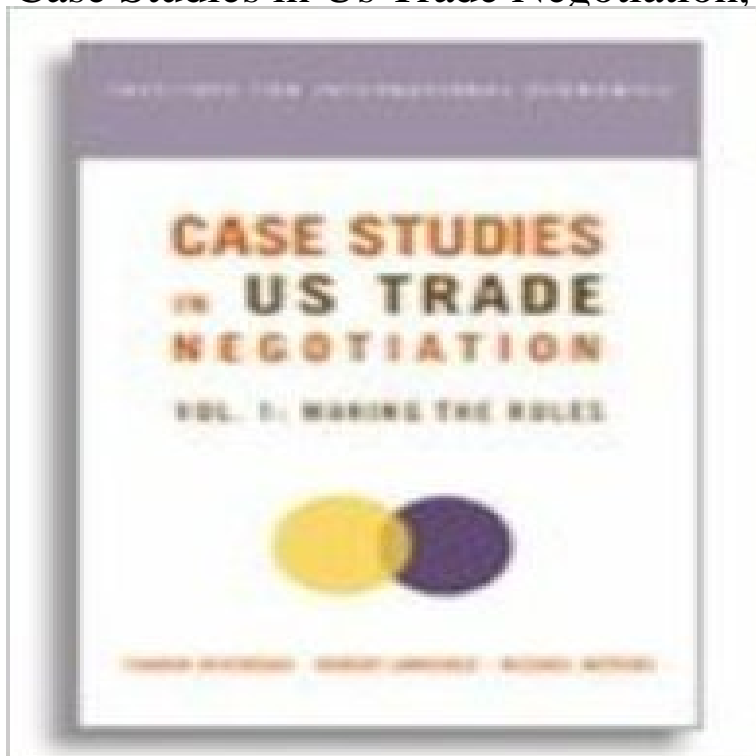


Case Studies in Us Trade Negotiation, Volume 1: Making the Rules
