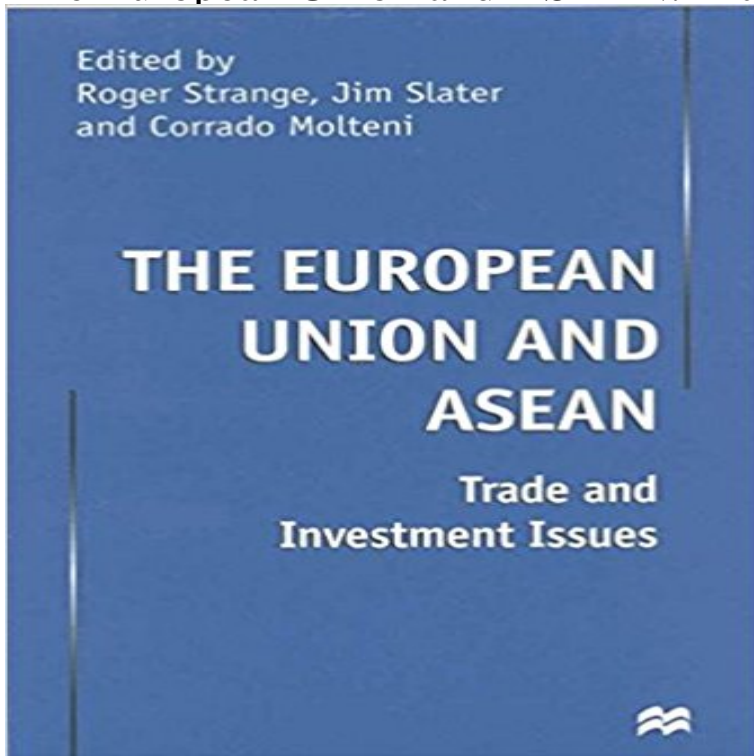


# The European Union and ASEAN: Trade and Investment Issues

Prior to the crisis, the ASEAN markets were becoming increasingly important destinations for exports from the European Union (EU), and more important locations for EU foreign direct investment (FDI). ASEAN exports and FDI to the EU were also increasing.
