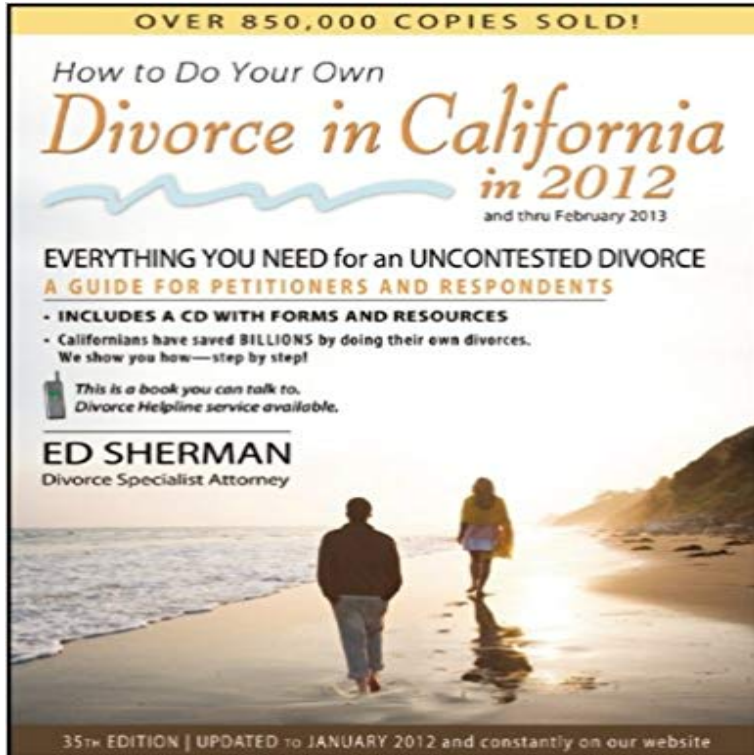


# How to Do Your Own Divorce in California in 2012: Everything You Need for an Uncontested Divorce
