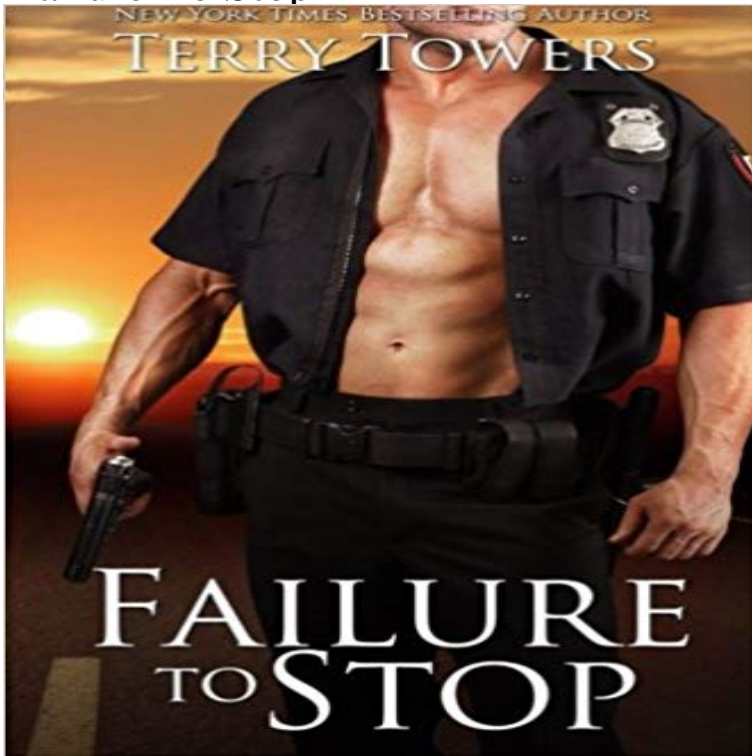


Failure To Stop
