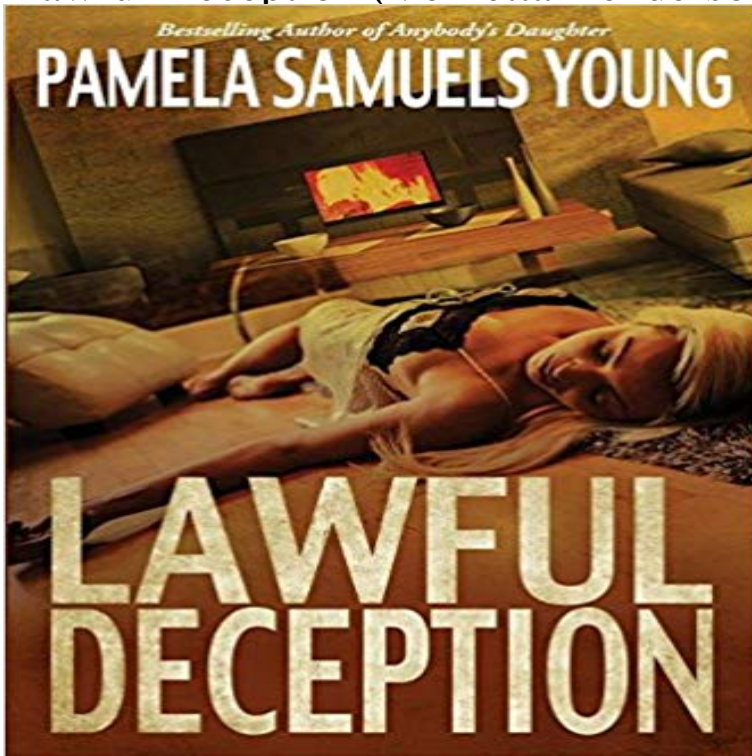


## Lawful Deception (Vernetta Henderson Series, Book 5)
