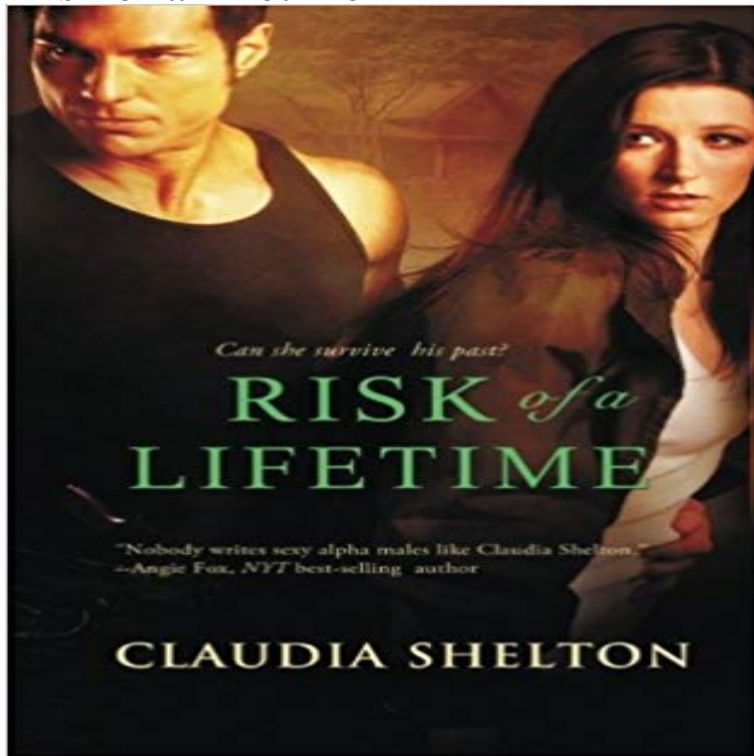


## Risk of a Lifetime
