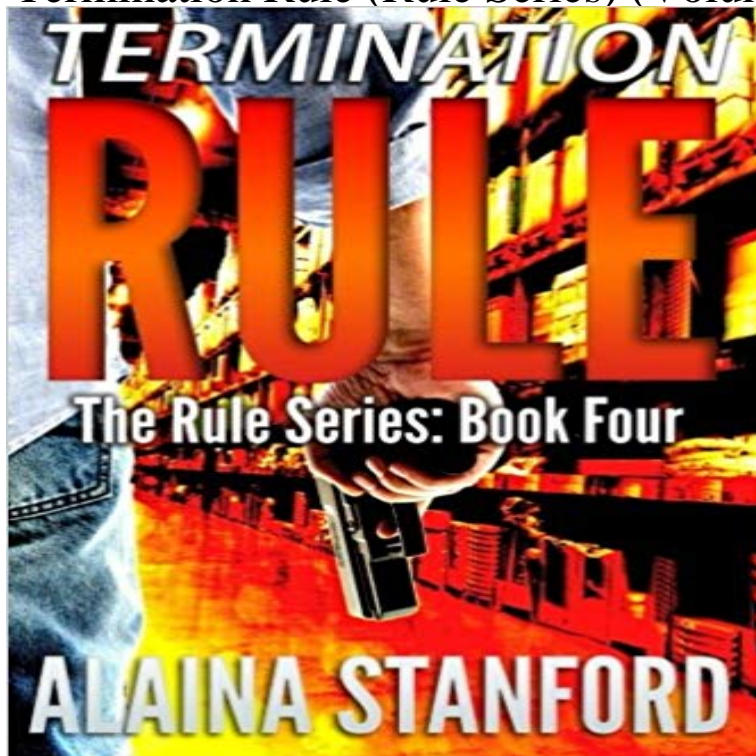


Termination Rule (Rule Series) (Volume 4)
