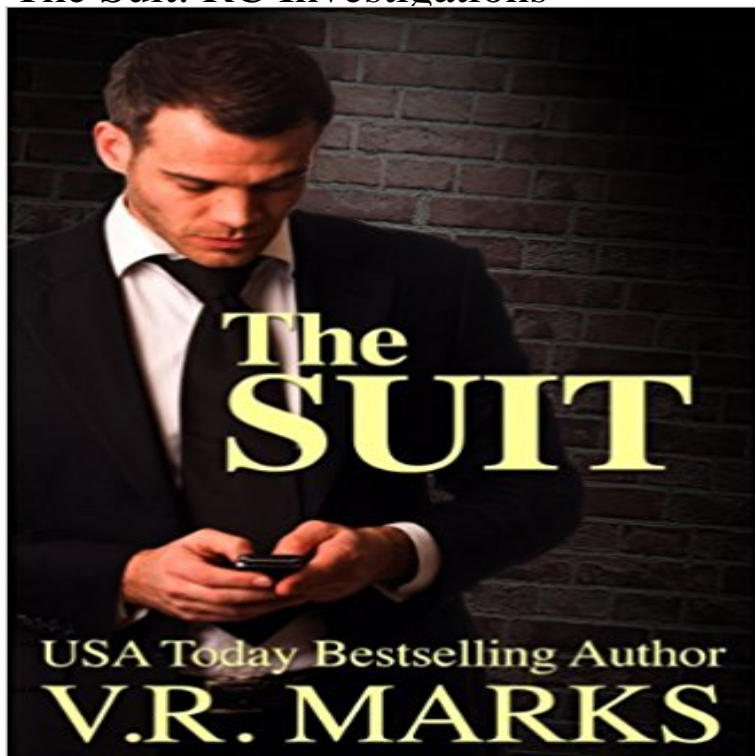


## The Suit: RC Investigations
